At the last meeting of the Chapter and Council the By-Laws committee proposed and read 5 Resolutions, which will be read for the second time and voted on for adoption at the next Stated Commandery Conclave. The Commandery was opened for the purpose of reading these resolutions. I will summarize them here: Resolution # 1 will increase the dues for Chapter \$10.00 or from \$10.00 annually to \$20.00 plus the per-capita assessment which is \$15.00. Resolution # 2 will increase the Council dues \$10.00 or from \$ 10.00 to \$20.00 annually plus the per-capita. Resolution # 3 will increase the Commandery dues \$10.00, or from \$12.00 to \$22.00 annually plus the per-capita assessment. In recent years our expenditures have exceeded our income which is the necessity for the increase in dues. The total amount of yearly dues will be \$112.00 for all 3 bodies. Resolution # 4 addresses a change the meeting time for Chapter. If adopted, Eureka Chapter # 7 will meet on the 2nd Thursday of each odd numbered month.

Resolution # 5 addresses a change of meeting time for Orlando Council to the 2nd Thursdays of each even numbered month.

Resolutions # 4 and # 5 mean that Chapter will meet only 6 times a year, and Council will meet only 6 times a year. No longer will they meet together on the same night, one after the other. This change will allow each body to meet singularly and be able to spend their time more productively and also make the evening shorter.

The adoption of these 5 resolutions will allow us time to have them approved by the Grand Bodies and become effective in the ensuing year, 2016.

These resolutions will be voted on for adoption at the next Stated Commandery meeting, October 22, 2015. Eureka Chapter and Orlando Council will be opened for the purpose of voting on the resolutions to their respective By-Laws. We hope to see you at this meeting .

We want to welcome and congratulate our 2 newest Companions and Sir Knights as York Rite Masons, Chester A King and Lawrence J. McCann. They have embarked on a new journey in their search of Light, and we wish their search is very rewarding and enlightening one.
